





## Fire Prevention-Hazard Abatement

#### Definitions

Qualified Holder only covers = Forest Act section 12(1)(a)

- 1. Forest Lic.
- 2. Timber Lic.
- 3. TFL
- 4. Community Forest Lic.
- 5. Woodlot Lic.
- And 12(2)(a)-TSL

#### Fire Prevention-Hazard Abatement Time Lines

#### Wildfire Regulation 12.1(2)(a)-

Within the Regional District fire protection area +2km requires person to abate no later than 24 months.

#### Wildfire Regulation 12.1(2)(b)(i)-

Outside the Regional District fire protection area +2km requires person to abate no later than 30 months.

## Fire Prevention-Hazard Abatement Assessments

Wildfire Regulations 11(2)(a)&(3)(a)-

-Refers to hazard assessments required at <mark>3 months intervals inside Regional district fire protection area +2km.</mark>


OR

-6 months intervals outside Regional District fire protection area +2km

-Contact the local Senior Wildfire Officer of Prevention for more guidance on the assessment process


#### Fire Prevention-Ministry of Enviro: Open Burning Smoke Control Regulation (OBSCR)

- BCWS has provided feedback on the use of a "community wildfire risk reduction" objective
- BCWS will be collaborating on key messaging on the release of OBSCR regarding the role of prescribed fire (and related smoke) is necessary in maintaining healthy ecosystems
- BCWS will continue to support Resource Management Open Fire burns consistent with best practices under OBSCR.
- To be signed off by the Minister April 2019




