Honourable Katrine Conroy, Minister of Forests

Katrine Conroy was first elected as the MLA for Kootenay West in May 2009 and has represented the West Kootenays since 2005.

Katrine previously served as the Minister of Children and Family Development and worked to make life better for families across the Province.

Katrine had a varied career before becoming an MLA. She was one of B.C.'s first female power engineers and worked as an early childhood educator, administrator, college instructor, and a small business person.

Katrine has worked and volunteered in her community as the executive director of Kootenay Family Place, an instructor at Selkirk College; co-chair of the Castlegar and District Social Planning Council, treasurer of the Regional District of Central Kootenay Community Futures Board and founding board member of the Community Social Services Employers Association. Katrine lives in Pass Creek on a ranch breeding prize-winning Polled Hereford cattle. She has four children and nine grandchildren.

<u>Matt Austin, Assistant Deputy Minister, Integrated Resource Operations Division, Ministry of Forests</u>

Matt has over 25 years of experience working in the natural resource sector of the B.C. Public Service having had roles in a number of ministries and a diverse array of program areas. Matt holds a Master of Environmental Design (Environmental Science) from the University of Calgary and an Honors Bachelor of Science (Zoology) from the University of Western Ontario.

Matt was appointed Assistant Deputy Minister of Integrated Resource Operations Division in April 2018 and is responsible for a diverse portfolio. The division includes the Archaeology, Compliance & Enforcement, Fish & Wildlife, Water Management, Forest Tenures, Engineering, Lands and Crown Land Opportunities and Restoration branches.

George has been the Manager of the Wells Gray Community Forest (CF) tenure since its inception in 2006. He is a Registered Forest Technologist with over 28 years of silviculture, small scale forest management, forest harvesting and wildfire and forest fuel planning and management.

George has played an active role on the executive BC Community Forest Association's (BCCFA) Board of Directors from 2014 to 2019. In 2022, he respectfully accepted the position as the President of the BCCFA after a two year leave. He currently provides oversight and is responsible for the planning and coordination of the Wells Gray CF annual operating plan and long-term objectives. He is passionate about managing the landscape to create climate resilient forests that can continue to provide social, economic, and environmental benefits to communities. He strongly believes in the connection between healthy forests and healthy people, which drives his daily work.

He believes that Community Forest tenures are an opportunity to lead the province in sustainable forest management with an appreciation and respect for the lands and people of British Columbia. When he is not working in the forest, he can be found hiking or touring up mountains in the beautiful interior of BC.

Callum Cathro

Callum started working in the forest industry 10 years ago first as a tree planter and eventually pursued his education in forestry at Selkirk College. Since then, Callum has gone on to work with Indigenous Bands and Community Forests throughout the West Kootenays and Northern British Columbia. Callum now lives in Nelson BC where he works seasonally as a wildland Fire Fighter, and is working on wildfire mitigation projects in the winter.

John Cathro is Registered Professional Forester and independent consultant. His clients include First Nations, communities, companies, organizations and governments across BC and around the world. He works on issues that include community wildfire protection, third-party certification, strategic land use planning and conservation area management. John has over 20 years experience working within complex multi-party situations involving jurisdiction, economic development, and cultural and ecological conservation. His approach is grounded in technical expertise and based on collaboration and capacity building. John has graduate degrees in forestry and land use from Oxford University and conflict management from Royal Roads University. John and his family live in Kaslo, BC.

Lori Daniels, Professor UBC & Research Team Kelsey Copes-Gerbitz and Kea Rutherford

Lori Daniels is a Professor of Forest Ecology in the Department of Forest and Conservation Sciences, where she directs the Tree-Ring Lab at UBC. Dr. Daniels' research investigates the impacts of natural and anthropogenic disturbances and climate change on temperate forests in North and South America.

With her graduate students, Dr. Daniels has on-going research on wildfires, forest dynamics, and social-ecological resilience to climate change in coastal and interior British Columbia, the Rocky Mountain National Parks, foothills of Alberta and northern Patagonia. Her research at UBC is supported by several prestigious grants including NSERC Discovery, Natural Resources Canada Climate Change Adaptation, Wall Solutions Initiative from the Peter Wall Institute for Advanced Studies, and a grant from the Intact Foundation to support ongoing collaboration with the St'uxwtéws Band.

Beth Eagles, RPF, District Manager, Nadina Resource District with the Lakes Resiliency Project

Beth Eagles is currently the District Manager of the Nadina Natural Resource District which includes the Lakes and Morice Timber Supply Areas. The office is situated in Burns Lake and the district encompasses the traditional territories of the Wet'suwet'en, Carrier Sekanni and Lake Babine Nations.

Beth is a registered professional forester and a graduate from the University of New Brunswick. She has worked for the government for 22 years in district, regional and branch positions and in the communities of Fort Nelson, Kamloops, Victoria and Burns Lake. Prior to joining government, she worked for a consultant in Alexis Creek.

Beth is also the co-chair of the Technical Planning Table for the Lakes Resiliency Project. The Project was initiated as a response to the 2018 wildfires and it's goal is to develop land use objectives and a forest landscape plan that will establish a more resilient forested land base and contribute to community stability.

Since graduating from UBC Forestry Dave has worked for industry, his own consultancy, government, and First Nations in various locations across British Columbia. Since 1999 Kelowna has been home for him and his family.

Today, Dave's primary interest is in advancing ways to incorporate Indigenous and community values into all aspects of forest stewardship on WFN-held tenures and to continue earning the support of and developing opportunities for the WFN Community.

The project is designed to demonstrate how managers can integrate climate science and risk assessment into practical forestry decision-making in the Columbia Basin.
