The Three Rivers Community Forest to manage local forests around Quesnel – After many years of collaboration, a Community Forest Agreement (CFA) has been issued for Quesnel and surrounding area.

The Three Rivers Community Forest (TRCF) is an agreement between Lhtako Dene, Nazko, ?Esdilagh, and Lhoosk'uz First Nations along with the City of Quesnel to enable the municipality and First Nations to manage local forest resources in the area.

TRCF is a Limited Partnership between the 5 governments and will enable sustainable forest management practices on ~33,000 hectares of Crown land. With an annual allowable cut of up to 42,850m3/year of conifer trees and 10,000m3/year of deciduous trees. The TRCF is a perpetual area-based licence with renewal taking place every 25 years.

Under a community forest agreement, the 5 partner communities will work with residents to identify priorities and perform activities such as: integrated fuel management to reduce wildfire risk, ensuring ecosystem resiliency through innovative forest management, collaborating on trails and other recreation initiatives, integrating First Nations traditional and ecological knowledge as well as local knowledge into land management, and uphold economic diversification that supports a thriving local economy.

Ultimately, the Three Rivers Community Forest is enabling strategic alliances and collaborative land management to promote greater community resiliency and aims to realize additional resources and value from the land base and keep benefits local.

The management board of the Three Rivers Community Forest is comprised of one appointed member from each of the partner governments. The management board of the TRCF released a collective statement: "Obtaining the community forest agreement after so many years of collaboration and hard work is a testament to what can be achieved when all of the governments work together. Three Rivers Community Forest is allowing us to come together as neighbours and co-managers of the forest ecosystem that we all call home, while realizing the collective benefits and well-being for all of our communities."

Being a community led initiative, the Three Rivers Community Forest is committed to working with and for local residents and is committed to hosting community meetings and actively communicating via newsletters, website and other means. The TRCF is now actively looking for a Manager and expects to begin operations in the new year.
