


Overview of changes in the last year

FRPA Transition

- FPC repealed Jan 2004
- Any FDP (existing or submitted during transition) is valid till its term date in approval letter expires or it is replaced with a FSP
- Transition period ended Dec 31, 2005.
- Community Forests now have to do FSP (under FPPR)

PCFA Assessments

- 4 assessments done over the last year (McBride, Harrop Proctor, Likely, Cheslatta)
- 1 long term licence offered (McBride)
- Cheslatta voluntarily withdrew their report & will be providing updated info
- HP, BN currently being done & will have a response to HP by end of June
- Likely: review just recently done, some additional info requested; provided earlier this week.

Invitations/Applications

- invitations sent out to 14 communities over the last year totalling 404,000m3
- 6 applications were submitted & reviewed (Sechelt, Powell River, Terrace, Wells Gray, Lower N. Thompson, & Prince George)
- Sechelt earlier this week was issued a PCFA


